April 15 Deadline: A person may donate prior to filing taxes, but no later than April 15, and claim the credit for the previous year's taxes. There are no extensions, so donations must be postmarked or entered online no later than midnight, April 15.

Donor Recommendations and Eligibility: You may recommend a student, school or PSTF123's general scholarship fund. The final determination on scholarship awards are subject to the absolute discretion of PSTF123 as regulated by the Arizona Department of Revenue. Scholarships will be awarded without any regard to the student's race, color, disability or familial status. Scholarships are used for K-12 students attending private schools in Arizona. Ninety percent of donated funds received will be used for scholarships.

Note: A school tuition organization cannot award, restrict, or reserve scholarships only on the basis of a donor's recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent. A.R.S. 43-1603 (C). Any designation of your own dependent as a potential recipient is prohibited.

DID YOU KNOW?

*You can choose to have PSTF123 withdraw your approved donation amount monthly from your credit card or checking account.

*Arizona state law (A.R.S.43-401(I)) allows individuals to authorize their employer to send their state withholding tax amount to PSTF123 as **DOLLAR-FOR-DOLLAR** tax credit donation!
